**Sub: Armed security personnel at the gates in all JNVs, need of the hour—  
reg**

Sir,

In the wake of putting to flames the motorcycle and the scooter of a regular teacher named Sh.P.K.Panda, Pgt Physics, in the premises of Jawahar Navodaya Vidyalaya Cuttack, Orissa., Navodaya Vidyalaya Employees Welfare Association (NVEWA) condemns this vandalism outrightly and urges Navodaya Vidyalaya Samiti to deploy armed security personnels at the gates in all JNVs.

1. There ought to be 'zero-tolerance' to such hooliganism, vandalism inside the premises of a co-ed residential school. A fair investigation into the matter is called forth, for the brutal incident of JNV Cuttack, directly by NVS Hqr officials. This incident be viewed very seriously, Sir. This wanton mischief/vandalism invites criminal prosecution u/s 425 of the Indian Penal Code, 1860 . apart from initiating departmental disciplinary proceedings thereto.

This letter of request for armed personnels as security guards at the gates of JNVs be taken as a proactive measure, taking into consideration the safety and security of the lives of four hundred children or so, in almost in all JNVs ; for the safety of the staff with their families staying in these co-ed residential schools in the country.

Please expedite the process of deploying armed security personnel at the gates in all the JNVs as envisaged in prior circulars of even dates by NVS, of utilising the "Outsourcing Security-service providers" for the same.

Secondly, howsoever, unfortunately, if the students of this JNV Cuttack- the culprits, and accountable for this juvenile vandalism , then the delinquents be removed from this JNV immediately by issuing a Transfer Certificate (TC), to check and deter other students in other JNVs in all Regions from committing such heinous crimes in the JNVs . Herein, it is to be stated that proper guidelines is to be framed by NVS headquarter for severe indiscipline acts by the students in JNVs : such as rustication, and removal from JNVs and procedure for the same., vis-à-vis the brooming adolescence misdemeanour, in this era. A “Manual for Prevention of Indiscipline Acts by Students” released by NVS hqrs, in this behalf , would be a welcome step -- to have a peaceful , harmonious and studious atmosphere in JNVs.


With a plea ,for a positive consideration by your highness of the safety and security of staff and students residing in JNV Cuttack and a prompt stringent action to the miscreants ....
